## ORDINANCE NO. 19- O(

AN ORDINANCE ANNEXING CERTAIN CONTIGUOUS LAND TO THE VILLAGE OF MANLEY, NEBRASKA, AND DEFINING THE BOUNDARIES THEREOF.

## BE IT ORDAINED BY THE CHAIRMAN AND THE VILLAGE BOARD OF THE VILLAGE OF MANLEY, NEBRASKA:

**SECTION 1.** That the land to be annexed is contiguous to the corporate limits of the Village of Manley, Nebraska, and is urban or suburban in character.

- n. Tax Lot 17, an Administrative Subdivision located in the NE  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  of Section 15-11-11, East of the  $6^{th}$  P.M. Cass County, Nebraska.

SECTION 3. That from and after the date of annexation, the inhabitants of said annexed territory shall be subject to all of the Ordinances, Rules and Regulations of the Village of Manley, Nebraska, and shall enjoy all of the rights and privileges as other citizens of said Village
